WHEREAS the Publisher holds the rights granted under the License.

AND WHEREAS the Licensee desires to use the rights and the Publisher desires to grant to the Licensee the license to use the rights for the Fee, subject to the terms and conditions of the License.

IT IS AGREED AS FOLLOWS:

### 1. KEY DEFINITIONS

1.1 In the License, the following terms shall have the following meanings:

**Agent:** A third party appointed from time to time by the Licensee to act on the Licensee's behalf, who may undertake any or all of the obligations of the Licensee under the License, as agreed between the Licensee and the Agent.

#### Authorized Users:

*For academic institutions:* ("Academic Institutions"): (i) Then-current members of the faculty and other staff of the Licensee (whether on a permanent, temporary, contract or visiting basis) employed at the Licensee's Premises; (ii) individuals who are enrolled at the Licensee's Academic Institution located on the Licensee's Premises who are permitted to access the Secure Network from within the Library Premises or from such other places where Authorized Users work or study (including but not limited to Authorized Users' offices and homes, halls of residence and student dormitories) and who have been issued a password or other authentication from the Licensee; and (iii) other persons who access the Secure Network from computer terminals within the Library Premises and are permitted to use the Library Premises.

*For corporations:* Current members of the staff (whether on a permanent, temporary or contract basis) of the Licensee who are employed at the Licensee's Premises and are permitted to access the Secure Network from within the Licensee's Premises or from such other places where such staff undertake their work for the Licensee (including but not limited to Authorized Users' offices and homes) and who have been issued a password or other authentication by the Licensee.

*For public libraries:* (i) Current members of the staff of the Licensee (whether on a permanent, temporary or contract basis) who are employed at the Licensee's Premises and are permitted to access the Secure Network from within the Library Premises or from such other places where such staff undertake their work for the Licensee and who have been issued a password or other authentication by the Licensee; and (ii) members of the public (patrons) who are permitted to use the Licensee's library and access the Secure Network only from computer terminals within the Library Premises.

**Commercial Use:** Use for the purposes of monetary reward (whether by or for the Licensee or an Authorized User) by means of sale, resale, loan, transfer, hire or other form of exploitation of the Licensed Materials. For the avoidance of doubt, neither recovery of direct costs by the Licensee from Authorized Users, nor by use by the Licensee or by an Authorized User of the Licensed Materials in the course of research funded by a commercial organization is deemed to be Commercial Use.

**Course Packs:** A collection or compilation of materials (e.g. book chapters, journal articles) made and stored on the Secure Network by the Licensee for use by students in a class for the purpose of instruction.

**Electronic Reserve:** Electronic copies of materials (e.g. book chapters, journal articles) made and stored by the Licensee on the Secure Network for use by students in connection with specific courses of instruction offered by the Licensee to its students.

**Fee:** The Fee set out in Schedule 1 or in new Schedules to this License which may be agreed upon by the parties from time to time.

**Library Premises:** The physical premises of the library or libraries operated by the Licensee, as specified in Schedule 2.

**Licensed Materials:** The electronic material as set out in Schedule 1 or in new Schedules to this License that may be agreed upon by the parties from time to time.

**Secure Network:** A network (whether a standalone network or a virtual network within the Internet), which is only accessible to Authorized Users, approved by the Licensee whose identity is authenticated at the time of login and periodically thereafter consistent with current best practice, and whose conduct is subject to regulation by the Licensee.

**Server:** The server, either the Publisher's server or a third party server designated by the Publisher, on which the Licensed Materials are mounted and may be accessed.

**Subscription Period:** That period nominally covered by the volumes and issues of the Licensed Material listed in Schedule 1, regardless of the actual date of publication.

## 2. AGREEMENT

2.1 The Publisher shall agree to grant to the Licensee the non-exclusive and non-transferable right, throughout the world, to give Authorized Users access to the Licensed Materials via a Secure Network subject to the terms and conditions of this License, and the Licensee agrees to pay the Fee. The Licensee will pay the Fee direct to the Publisher; unless the Licensee directs that the Agent shall be responsible for processing payment of the Fee (and shall be entitled to receive any refund of the Fee) on behalf of the Licensee.

2.2 This License shall commence at the beginning of the Subscription Period, for the Licensed Materials as set out in Schedule 1 or in new Schedules to this License that may be added subsequently.

### **3. USAGE RIGHTS**

3.1 The Licensee, subject to clause 6 below, may:

3.1.1 Make such temporary electronic copies by means of caching of all or part of the Licensed Materials as are necessary solely to ensure efficient use by Authorized Users and not to make available to Authorized Users duplicate copies of the Licensed Material.

3.1.2 Allow Authorized Users to have access under 3.2 to the Licensed Materials from the Server via the Secure Network.

3.1.3 Display, download, or print the Licensed Materials for the purpose of internal testing or for training Authorized Users in respect of which appropriate acknowledgement of the source shall be made.

3.2 Authorized Users may, subject to clause 6 below:

3.2.1 Search, view, retrieve and display the Licensed Materials.

3.2.2 Electronically save parts of the Licensed Materials for personal use only, as per section 107 of the 1976 Copyright Law, which outlines the guidelines for fair use.

3.2.3 Print off single copies of parts of the Licensed Materials for personal use, as per Section 107 of the 1976 Copyright Law, which outlines the guidelines for fair use.

3.3 Nothing in this License shall in any way exclude, modify or affect any of the Licensee's rights under Copyright Revision Act 1976 as amended subsequently provided that such rights are exercised in accordance with Section 108 of the Act and with the guidelines developed by the National Commission on New Technological Uses of Copyrighted Works (CONTU Guidelines) and published in U.S. Copyright Office Circular 21.

### **4. INTER-LIBRARY LENDING**

4.1 Notwithstanding the provisions of Clauses 3.1 and 3.3, it is understood and agreed that neither the Licensee nor Authorized Users may provide, by electronic means, to a user at another library outside of the Licensee's secure networks a copy of any part of the Licensed Materials for research or private study or otherwise.

### **5. COURSE PACKS AND ELECTRONIC RESERVE**

5.1 For the avoidance of doubt, the Licensee may not incorporate all or any part of the Licensed Materials in Course Packs and Electronic Reserve collections without the prior written permission of the Publisher, which may set out further terms and conditions for such usage.

### **6. PROHIBITED USES**

6.1 Neither the Licensee nor Authorized Users may:

- 6.1.1 Remove or alter the authors' names or the Publisher's copyright notices or other means of identification or disclaimers as they appear in the Licensed Materials.
  - 6.1.2 Systematically make print or electronic copies of multiple extracts of the Licensed Materials for any purpose.
  - 6.1.3 Mount or distribute any part of the Licensed Material on any electronic network, including without limitation the Internet and the World Wide Web, other than the Secure Network.
- 6.2 The Publisher's explicit written permission must be obtained in order to:
- 6.2.1 Use all or any part of the Licensed Materials for any Commercial Use; systematically distribute the whole or any part of the Licensed Materials to anyone other than Authorized Users;
  - 6.2.2 Publish, distribute, or make available the Licensed Materials, works based on the Licensed materials, or works that combine them with any other material, other than as permitted in this License;
  - 6.2.3 Alter, abridge, adapt, or modify the Licensed Materials, except to the extent necessary to allow them to be viewed on a computer screen to Authorized Users. For the avoidance of doubt, no alteration of the words or their order is permitted.

### **7. PUBLISHER'S UNDERTAKINGS**

- 7.1 The Publisher warrants to the Licensee that the Licensed Materials used as contemplated by this License do not infringe the copyright or any other proprietary or intellectual property rights of any person. The Publisher shall indemnify and hold the Licensee harmless from and against any loss, damage, costs, liability and expenses (including reasonable legal and professional fees) arising out of any legal action taken against the Licensee claiming actual or alleged infringement of such rights. This indemnity shall survive the termination of this License for any reason. This indemnity shall not apply if the Licensee has amended the Licensed Materials in any way not permitted by this License.
- 7.2 The Publisher shall:
- 7.2.1 Make the Licensed Materials specified in Schedule 1 available to the Licensee from the Server.
  - 7.2.2 Use reasonable endeavors to make available the electronic copy of each journal issue in the Licensed Materials not later than the mail date of the printed version.
  - 7.2.3 Use reasonable efforts to notify the Licensee in advance of any anticipated specification change applicable to the Licensed Materials.
  - 7.2.4 Use reasonable endeavors to ensure that the Server has adequate capacity and bandwidth to support the usage of the Licensee at a level commensurate with the standards of availability for information services of similar scope operating via the World Wide Web, as such standards evolve from time to time over the term of this License.

- 7.2.5 Use reasonable endeavors to make the Licensed Materials available to the Licensee and to Authorized Users at all times and on a twenty-four hour basis, save for routine maintenance (which shall be notified to the Licensee in advance whenever possible), and to restore access to the Licensed Material as soon as reasonably possible in the event of an interruption or suspension of the service.
- 7.2.6 Use reasonable endeavors to provide the Licensee with adequate and competent support and assistance via a designated contact supplied by the publisher.
- 7.3 The Publisher reserves the right, at any time, to withdraw from the Licensed Materials any item or part of an item for which it no longer retains the right to publish, or which it has reasonable grounds to believe infringes copyright or is defamatory, obscene, unlawful, or otherwise objectionable. The Publisher shall give written notice to the Licensee of such withdrawal. If the withdrawal represents more than ten percent (10%) of the publication in which it appeared, the Publisher shall refund that part of the Fee that is in proportion to the amount of material withdrawn and the remaining unexpired portion of the Subscription Period.
- 7.4 EXCEPT AS EXPRESSLY PROVIDED IN THIS LICENSE, THE PUBLISHER MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, INCLUDING BUT NOT LIMITED TO, WARRANTIES OF DESIGN OR ACCURACY OF THE INFORMATION CONTAINED IN THE LICENSED MATERIALS. THE LICENSED MATERIALS ARE SUPPLIED "AS IS".
- 7.5 EXCEPT AS PROVIDED IN CLAUSE 7.1, UNDER NO CIRCUMSTANCES SHALL THE PUBLISHER BE LIABLE TO THE LICENSEE OR ANY OTHER PERSON, INCLUDING BUT NOT LIMITED TO AUTHORIZED USERS, FOR ANY SPECIAL, EXEMPLARY, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER ARISING OUT OF THE INABILITY TO USE, OR THE USE OF, THE LICENSED MATERIALS. IRRESPECTIVE OF THE CAUSE OR FORM OF ACTION, THE PUBLISHER'S AGGREGATE LIABILITY FOR ANY CLAIMS, LOSSES, OR DAMAGES ARISING OUT OF ANY BREACH OF THIS LICENSE SHALL IN NO CIRCUMSTANCES EXCEED THE FEE PAID BY THE LICENSEE TO THE PUBLISHER UNDER THIS LICENSE IN RESPECT TO THE SUBSCRIPTION PERIOD DURING WHICH SUCH CLAIM, LOSS OR DAMAGE OCCURRED. THE FOREGOING LIMITATION OF LIABILITY AND EXCLUSION OF CERTAIN DAMAGES SHALL APPLY REGARDLESS OF THE SUCCESS OR EFFECTIVENESS OF OTHER REMEDIES. REGARDLESS OF THE CAUSE OR FORM OF ACTION, THE LICENSEE MAY BRING NO ACTION ARISING FROM THIS LICENSE MORE THAN SIX (6) MONTHS AFTER THE CAUSE OF ACTION ARISES.

### **8. LICENSEE'S UNDERTAKINGS**

- 8.1 The Licensee shall:
- 8.1.1 Use its best efforts to ensure that all Authorized Users are appropriately notified of the importance of respecting the intellectual property rights in the Licensed Materials and of the sanctions that the Licensee imposes for failing to do so, in particular as specified in Schedule 3;

- 8.1.2 Use its best efforts to ensure that the Authorized Users are made aware of and undertake to abide by the terms and conditions of this License;
  - 8.1.3 Use its best efforts to monitor compliance and immediately upon becoming aware of any unauthorized use or other breach, inform the Publisher and take all reasonable and appropriate steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence;
  - 8.1.4 Provide the Publisher, within 30 days of the date of this Agreement, with information sufficient to enable the Publisher to provide access to the Licensed Material in accordance with its obligation under clause 7.2.1. Should the Licensee make any significant change to such information, it will notify the Publisher not less than ten (10) days before the change takes effect.
  - 8.1.5 Keep full and up-to-date records of all IP addresses and provide the Publisher with lists of additions, deletions or other alterations to such records as agreed between the parties from time to time;
  - 8.1.6 Use all best efforts to ensure that only Authorized Users are permitted access to the Licensed Materials.
- 8.2 THE LICENSEE AGREES TO INDEMNIFY, DEFEND AND HOLD THE PUBLISHER HARMLESS FROM AND AGAINST ANY LOSS, DAMAGE, COSTS, LIABILITY, AND EXPENSES (INCLUDING REASONABLE LEGAL AND PROFESSIONAL FEES) ARISING OUT OF ANY CLAIM OR LEGAL ACTION TAKEN AGAINST THE PUBLISHER RELATED TO OR IN ANY WAY CONNECTED WITH ANY USE OF THE LICENSED MATERIALS BY THE LICENSEE OR AUTHORIZED USERS OR ANY FAILURE BY THE LICENSEE TO PERFORM ITS OBLIGATIONS IN RELATION TO THIS LICENSE, PROVIDED THAT NOTHING IN THIS LICENSE SHALL MAKE THE LICENSEE LIABLE FOR BREACH OF THE TERMS OF THE LICENSE BY ANY AUTHORIZED USER PROVIDED THAT THE LICENSEE DID NOT CAUSE, KNOWINGLY ASSIST, OR CONDONE THE CONTINUATION OF SUCH BREACH TO CONTINUE AFTER BECOMING AWARE OF AN ACTUAL BREACH HAVING OCCURRED.
- 8.3 The Licensee will, in consideration for the rights granted under this License, pay the Fee upon signing the agreement. For the avoidance of doubt, the Fee shall be exclusive of any sales, use, value added or similar taxes and the Licensee shall be liable for any such taxes in addition to the Fee.

### **9. UNDERTAKINGS BY BOTH PARTIES**

- 9.1 Each party shall use its best efforts to safeguard the intellectual property, confidential information and proprietary rights of the other party.

### **10. TERM AND TERMINATION**

- 10.1. The term of this Agreement shall commence on the Effective Date and shall continue until terminated under Section 10.2 of this Agreement. At least sixty (60) days prior to the end of each calendar year during the term, the Publisher shall provide the Licensee with written notice of the Subscription Fee for the subsequent calendar year (the "Notice").
- 10.2. This Agreement may be terminated under the following circumstances:

- 10.2.1. If the Licensee fails to pay any Fee owed by the Licensee by the date specified in the applicable Notice and fails to remedy such default within thirty (30) days after the date that the Licensee receives written notice of such default from the Publisher, then the Publisher may terminate this Agreement immediately;
- 10.2.2. If either party materially breaches the Agreement and fails to cure such breach within sixty (60) days after the date that the breaching party receives written notice from the other party of such breach, then the non-breaching party may terminate this Agreement;
- 10.2.3. If either party becomes subject to receivership, liquidation, or similar external administration, then the other party may terminate this Agreement; and
- 10.3. On expiration or termination of this Agreement, all rights and obligations of the parties automatically terminate except that (i) the Licensee may continue to make available to its Authorized Users the printed copies of the Licensed Materials that were delivered by the Publisher to the Licensee during the term of this Agreement.
- 10.4. On expiration or termination of this Agreement, except as provided under Section 10.3, the Licensee shall immediately cease to distribute or make available the Licensed Materials to any third party and shall remove all Licensed Materials posted on the Licensee's Secure Network.
- 10.5. If the Licensee terminates this Agreement under Section 10.2.2, the Publisher shall promptly refund to the Licensee a pro rata portion of the Subscription Fee paid by the Licensee under this Agreement based on the amount of time remaining in the then-current term.

### **11. GENERAL**

- 11.1 This License constitutes the entire agreement of the parties and supersedes all prior communications, understandings and agreements relating to the subject matter of this License.
- 11.2 Alterations to this License and to the Schedules to this License are only valid if they are recorded in writing and signed by both parties.
- 11.3 This License may not be assigned by the Licensee to any other person or organization without the prior written consent of the Publisher, which consent shall not unreasonably be withheld. The Publisher may assign this License without the consent of the Licensee.
- 11.4 If rights in all or any part of the Licensed Materials are assigned to another publisher, the Publisher shall use its best efforts to ensure that the terms and conditions of this License are maintained.
- 11.5 Any notices to be served on either of the parties by the other shall be sent by prepaid recorded delivery or registered post to the address of the addressee as set out in this License or to such other address as notified by either party to the other at its address for service of notices. All such notices shall be deemed to have been received within 14 (fourteen) days of posting.
- 11.6 Neither party's delay or failure to perform any provision of this License, as a result of circumstances beyond its control (including, without limitation, war, strikes, floods, governmental restrictions, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) shall be deemed to be, or to give rise to, a breach of this License.

- 11.7 The invalidity or un-enforceability of any provision of this License will not affect the continuation or enforceability of the remainder of this License.
- 11.8 Either party's waiver, or failure to require performance by the other, of any provision of this License will not affect its full right to require such performance at any subsequent time, or be taken or held to be a waiver of the provision itself.
- 11.9 The courts of the Commonwealth of Virginia, USA, shall have exclusive jurisdiction over any disputes arising in connection with this Agreement. This Agreement shall be governed and construed in accordance with the laws of the Commonwealth of Virginia, USA.
